(a)	<p>Brief details of litigation viz. name of the opposing party, Court/tribunal/agency where litigation is filed, brief details of dispute/litigation;</p> <p>A writ petition (PIL) No. 241 of 2018 is filed by Nareshbhai Mohanbhai Bhambhaniya &amp; 7 others (Petitioners) against the State of Gujarat and 11 others (Respondents) before Hon'ble Gujarat High Court. The Company is one of the Respondents in the said petition.</p> <p>The petition has challenged the Order passed by Collector for allotment of lands as well as the CRZ permission granted by Ministry of Environment Forests &amp; Climate Change, New Delhi.</p> <p>From preliminary observation of the impugned Petition, it appears to be completely devoid of merits and consists baseless allegations against government offices as well as processes defined under various laws which has been followed meticulously before Orders &amp; Permissions are granted. Company will submit its compliance in due course of time assimilating facts and merits.</p> <p>The Next date of hearing for the matter is January 07, 2019 as per the civil notice.</p>

(b)	Expected financial implications, if any, due to compensation, Penalty etc;	<p>There is no specific monetary compensation claim sought by the petitioners. However, petitioners have sought to quash the allotment orders passed by Collector &amp; CRZ permission granted by Ministry upon which wind turbines have been constructed/under construction, remove wind turbines installed in CRZ area and stop generation of energized wind turbines till final orders are passed.</p> <p>Wind turbines installed in CRZ are being developed under EPC Contract by Company. It had received contract on May 10, 2016 for installation of 24 wind turbines out of which, 13 falls in CRZ. As on date, 6 turbines are energized since March 30, 2018 and 7 are under various stages of development. Total value of contract is Rs. 39 crores for turbines falling within CRZ.</p> <p>All the wind turbines locations developed by Company have valid Land Orders and prior development permissions including CRZ permission from Ministry after obtaining NOCs &amp; scrutiny of various State &amp; Central Agencies as per laid process by Statutes. Company have sufficient grounds to refute allegations raised by petitioners and save from adverse financial impacts, if any in Courts of Law.</p>
(c)	Quantum of claims, if any;	<p>There are no monetary claims in the proceeding.</p>
