(a)	<p>Brief details of litigation viz. name of the opposing party, Court/tribunal/agency where litigation is filed, brief details of dispute/litigation;</p> <p>A Special Civil Application (SCA) No. 17093 of 2018 is filed by Makwana Harishbhai Jithabhai &amp; 4 others (Petitioners) against the Revenue Department and others (Respondents) before Hon'ble Gujarat High Court. The Company is one of the Respondents in the said petition.</p> <p>The petitioner has challenged the Order passed by Collector for allotment of land admeasuring 1-00-00 Hectare (one wind site location) at Village Ran, Distract Devbhumi Dwarka, Gujarat.</p> <p>From preliminary observation of the impugned Application, it appears to be completely devoid of merits and consists baseless allegations against government offices as well as processes defined under various laws which have been followed meticulously before Order is granted. Company will submit its compliance in due course of time assimilating facts and merits.</p> <p>The Next date of hearing for the matter is January 17, 2019 as per the civil notice.</p>
